DECISION

With regard to the procedure for recognizing the operating licence for the marketing of electricity granted by the National Energy Regulatory Authority in Romania, a Member State of the European Union, on April 29th, 2020, licence number 2213, on the basis of the application of the company AIK ENERGY ROMANIA SRL, having its headquarters at Șoseaua București-Ploiești 19-21, 1st district, 013696 Bucharest, Romania, filed with the Energy Regulatory Office on August 4th, 2020, the Energy Regulatory Office, as competent administrative authority according to Article 17, para. (6), letter (h) of the Law no. 458/Collection of 2000, on the conditions of entrepreneurship and the intervention of the State administration in the field of energy and amending certain laws (the Energy Law), as further amended and supplemented, decided, in accordance with Article 7a, para. (2) of the Law no. 458/ Collection of 2000 on the conditions of entrepreneurship and the intervention of the State administration in the field of energy and amending certain laws (the Energy Law), as further amended and supplemented, as follows:

- I. **The operating licence for marketing electricity in the Czech Republic granted to the foreign entity, the company AIK ENERGY ROMANIA SRL, having its headquarters at Șoseaua București-Ploiești 19-21, 1st district, 013696 Bucharest, Romania, by the National Energy Regulatory Authority in Romania, a Member State of the European Union on April 29th, 2020, licence number 2213, is hereby recognized,**
- II. **The licence is recognized until April 29th, 2030.**

Recommendations:

An appeal may be filed against this decision within 15 days from the date of its delivery in accordance with Article 81 of the Law no. 500/Collection of 2004, the Administrative Code, as further amended and supplemented (hereinafter the “Administrative Code”) in correlation with Article 152, para. (5) of the Administrative Code of the Energy Regulatory Office. The Council of the Energy Regulatory Office shall settle the appeal filed.

In accordance with Article 152, para. (5) of the Administrative Code in correlation with Article 85, para. (1) of the Administrative Code, the appeal results in postponement. The deadline for filing an appeal shall be calculated from the date following the delivery of this decision, but not later than ten days after the date on which the decision that was not handed over was filed and prepared to be picked up.
